



MILL STEEL COMPANY TERMS OF USE:

These Terms of Use (these “**Terms**” or this “**Agreement**”) govern your use of MillSteel.com, Mill Steel Link, and the Mill Steel App (individually the “**Site**” or the “**App**,” and collectively the “**Services**”) and constitute a license for your use of the Services. By accessing, viewing, or using the Services, you acknowledge that you have read, understand, and agree with these Terms. If you disagree with these Terms and the Mill Steel Privacy Policy at <https://www.millsteel.com/privacy-policy/> and/or do not wish to be bound by these Terms or the Privacy Policy, do not use the Services. By accepting these Terms of Use on behalf of a business, you represent and warrant that you have sufficient authority to bind the business, and that your acceptance of these Terms shall bind the company on whose behalf you are accepting these Terms.

YOUR USE OF MILL STEEL’S SERVICES

The Mill Steel Co. (“Mill Steel”). grants you a limited, nonexclusive, nontransferable, revocable license to use the Services subject to the restrictions set forth in these Terms of Use.

The Services are offered and available to users who have a business relationship with Mill Steel. By using the Services, you represent and warrant that you are of legal age to form a binding contract with Mill Steel and meet all of the eligibility requirements for doing so in the state in which you reside. If you are under the age of 18 and/or are otherwise unable to enter into a binding contract, you must not access the Services. These Terms shall be governed by and construed in accordance with the laws of the State of Michigan, without regard to its principles of conflicts of laws. By using one of the Services, you irrevocably submit to the exclusive jurisdiction of the courts of the State of Michigan located in Kent County, Michigan, and the United States District Court for the Western District of Michigan for the purpose of any suit, action, proceeding, or judgment relating to or arising out of these Terms. You irrevocably (i) consent to the jurisdiction of any such court in any such suit, action, or proceeding and to the laying of venue in such court; (ii) waive any objection to the laying of venue of any such suit, action, or proceeding brought in such courts; and (ii) waive any claim that any such suit, action, or proceeding brought in any such court has been brought in an inconvenient forum.

The Services are controlled by facilities in the United States of America. Mill Steel makes no representations that any of the Services are appropriate or available for use in other locations. If you access the Services from any location outside the United States of America, you do so at your own risk, and you are solely responsible for your compliance with all local laws and regulations.

These Terms of Use are the entire and exclusive agreement between Mill Steel and you regarding the Services, and these Terms of Use supersede and replace any prior agreements between Mill Steel and you regarding the Services.
